s PenSoft evolves we must make changes to our business practices as well as to our products and services to remain competitive and to provide the best products and services for our customers. After serious consideration there are two

major changes for 2011. We apologize for any inconvenience caused by these changes.

Software License

PenSoft Payroll and PenSoft Employee Tracker license agreements authorize use at only one physical location – multiple computers at the one location are allowed. This policy is not changing for 2011, however, due to ongoing flagrant violations of the license agreement, PenSoft will strictly enforce this policy for 2011. Therefore, the <u>software must be</u> <u>installed and registered at the physical location</u> where payroll will be processed. Download only users must download the software at this same location. You will not be able to register or use it at additional locations. It is not to be shared, sold, given or otherwise offered for use at any physical location other than the one where it is registered.

2011 Preordered 2011 PenSoft Payroll and PenSoft Employee Tracker Ship December 13, 2010

If the software is needed at more than one physical location, a software license must be purchased for each additional location. We will offer the renewal price (versus new customer price) for these

additional locations.

Offsite backups of the payroll data are highly recommended however this does not extend to installing the software at another physical location. In case of a disaster PenSoft can replace the software (download or CD) and assist in restoring your data as long as you have a saved backup.

Small Changes Make Big Differences in 2011 PenSoft Payroll

In select editions, 1099 functions and the invoicing program are also available for display directly to

the toolbar as well. The ability to toggle between the 1099 and Payroll mode can be added for ease in transition from

one function to the other. Valuing Your Employees

Windows[®] 2000

Microsoft[®] released its newest generation of development tools earlier this year eliminating support for the Windows 2000 operating system. Since all PenSoft software is developed using these tools our 2011 products will not support this operating system.

2011 PenSoft Payroll and PenSoft Time Online **will not operate in the Windows 2000** environment. If you are still using Windows 2000 either upgrade to a newer operating system (Windows XP, Windows Vista or Windows 7) or install the 2011 software on a different computer with one of these newer operating systems installed.

Q&A

Q. Why does Form 940 in PenSoft Payroll contain a watermark for Preliminary on the top of the form?

A. The Form 940 is an annual form and updates from the IRS are generally released later in the year. To ensure our customers are preparing forms using the latest updates, PenSoft places a watermark on the Form 940 until the last update has been released.

Q. How do I void a check for a Deposit type payment such as a 941 tax deposit entered in PenSoft Payroll?

A. To void Deposit Type Payment:

- Click Deposits on the toolbar.
- Select the Form 941 deposit from the list.
- Select Delete
- Click Void on the Delete/Void Tax deposits screen

The check is now voided.

Tips

Plain Paper Summaries

Protect employees sensitive account data when sending direct deposit summaries by displaying only the last four digits of the bank account number. Located in the Checks Window, users can click on Options for Plain Paper Summaries to activate.

Inactive Employees

Reduce errors and confusion by removing inactive employees from the Active list. Employees with current year data can be marked as inactive, and employees with no data for the current year can be archived. While displaying an employee setup, use the Status drop down option to make changes.
